Useful information	The qualification has been developed in response to the proposed early years foundation stage reforms for 2021 which highlighted that a sound knowledge and understanding of child development is needed for early years practitioners to fully support children's progress within the setting.  The qualification has been designed in collaboration with an external practitioner to enhance continuing professional development of learners in the early years workforce. It will provide them with knowledge and understanding of child development and its importance in supporting children's progress. Learners will become advocates of the importance of understanding child development in the early years by sharing their expertise with peers and colleagues in the workplace.
	The qualification is suitable for learners who are working in an early years setting and wish to enhance their continuing professional development by gaining an understanding of how children develop and cascading the knowledge by coaching and mentoring other practitioners.
	Learners must be over the age of 16 and have experience of working with babies and young children. It would be advantageous if the learners had already gained a level 2 or level 3 Early Years Educator or Early Years Practitioner qualification.
