

## 2021 to 2022 Pre-release dates

This document outlines the dates that pre-release material (where applicable) will be shared with T Level<sup>1</sup> providers for the summer 2022 series. For the 2022 to 2023 session and beyond, these dates will be incorporated into our key dates schedule.

The table below also contains some amendments already communicated to ensure providers receive material before the Easter 2022 holiday. The assessments affected are below, including the updated date for sharing pre-release materials with students. Note that in all cases tutor guidance documents will be shared at least 2 weeks before first assessments, and one week before the stated pre-release dates.

<b>T Level Technical Qualification in Education and Childcare (603/5829/4)</b>	Employer set project (ESP)	Friday 01 April 2022	Pre-release materials should be shared with students at least 3 weeks before the start of assessment, and tutors should check the students' pre-release work at least one week before the assessment.  The ESP assessment window opens on 03 May 2022. Students may use the Easter break to conduct the pre-release research task. Providers can share the preliminary material with students at any point from 01 April onwards.
	EYE OS, Assignment 1	Friday 01 April 2022	The assessment window opens on Monday 25 April 2022, with previous guidance that students must receive the preliminary materials no earlier than one week prior to this date.  However, given the timing of Easter, providers can share the preliminary material with students at any point from 01 April onwards.
	AT OS, Assignment 1	Friday 01 April 2022	The assessment window opens on Monday 25 April 2022, with previous guidance that students must receive the preliminary materials no earlier than one week prior to this date.  However, given the timing of Easter holiday, providers can share the preliminary material with students at any point from 01 April onwards.

Qualification	Assessment component	Date of pre-release	Pre-release guidance
<b>T Level Technical Qualification in Digital Business Services (603/6902/4)</b>	ESP	Friday 01 April 2022	<p>The pre-release task should be given to students so that they can complete it and have it checked by tutors at least one week before the assessment begins.</p> <p>The ESP assessment window opens on 09 May 2022. Students may use the Easter break to conduct the pre-release task. Providers can share the pre-release task with students at any point from 01 April onwards.</p>

For all assessments above, the pre-release material will be shared electronically, and can be shared with students once received, in line with guidance above. Students can work on the pre-release material throughout the Easter holiday in advance of the assessment starting, but providers must still ensure they meet the requirements of submission for tutor review where required.

For the below qualifications students do not receive a pre-release task before the assessment window opens but materials will be released early to support providers with planning and preparation.

Qualification	Assessment component	Date of release to providers	Pre-release guidance
<b>T Level Technical Qualification in Digital Support Services (603/6901/2)</b>	ESP	Monday 25 April 2022	The assessment begins on 09 May 2022. This component does not have a formal pre-release task; however, providers need access to the assessment material early for system configuration before students begin the assessment.
<b>T Level Technical Qualification in Health (603/7066/X)</b>	ESP	Wednesday 27 April 2022	<p>The assessment begins on 09 May 2022. The materials can be accessed by the provider 7 working days before the assessment window opens to support planning and preparation, allowing time to review the assessment requirements and guidance.</p> <p>Students are required to complete a pre-release research activity. This activity takes place <b>within</b> the 2 week assessment window. Students have 2 hours, under supervised conditions, to select and research one of the briefs. This must take place <b>before</b> the students are given the external assessment tasks, but <b>within</b> the 2 week assessment window. As per the tutor guidance document, this activity is classed as 2 hours preparation time, and is not included within the 14 hours 30 minutes allowed for the external assessment tasks.</p>
