About this qualification

This qualification provides learners with the skills and knowledge needed to manage practice and lead others in adult health and social care provision, or in children and young people's services.

It has five pathways:

Which cover a range of topics, including:

Qualification structure

Learners must achieve 90 credits and a minimum of 66 of these credits must be at/above Level 5.

- all mandatory units specific to their chosen pathway (from group C, D, E, F or G)
- and the remaining credits from Optional Groups H, I and J

It is anticipated that learners will be able to progress from advanced practitioner to manager status via this qualification. It is also anticipated that it will provide access to higher education opportunities.
