THEA 1: perform the non-scrubbed circulating role for perioperative procedures

Scenario

You are on rotation working in an operating theatre. You are helping the theatre practitioner set up the theatre for the first surgical procedure of the day.

This will include preparing the correct documentation for the theatre and procedure as well as following specific instructions for that theatre and the procedure that will be performed.

You will also bring equipment into the theatre and add equipment onto the sterile field without compromising its sterility.

Task 1

You are required to produce a reflective account.

You must fully respond to all the questions written below:

- referring to your knowledge and experience, explain the standard precautions to be carried out preoperatively on all the equipment in the theatre, including post operative checks (AC1.1)
- referring to your own knowledge and experience, explain the potential consequences of not following the above outlined preoperative and post operative checks on equipment (AC1.2)
- referring to your own knowledge and experience, explain the local systems and protocols for team time out, sign out and debriefing and its importance to the surgery (AC1.3)
- referring to your own knowledge and experience, explain local policies and procedures regarding the correct handling of contaminated items (AC1.4)
- referring to your own knowledge and experience of infection prevention control describe how to maintain a sterile field (AC1.5)
- referring to your own knowledge and experience of infection prevention control state the procedure to be followed when there is a breakdown in the sterile field (AC1.6)
- referring to local and national policies and procedures state how to dispose of contaminated or potentially hazardous waste. (AC1.7)

Scenario

A patient is coming for a lumbar decompression and fusion, this is an invasive procedure and will need specific equipment and surgical instruments. The patient will be in a prone position and will need plenty of support. A representative will also be present to advise during the procedure and will require you to hand over sterile single use items to the scrub practitioner without compromising the sterile field.

Scenario

The plastics list has 3 patients, a breast reconstruction, tendon repair on the hand, and axillary lymph node dissection. Each patient will need to be positioned in a different way, requiring different equipment for each procedure. The equipment used will be to make the areas operated on more accessible to the surgeon without compromising the patient. All the patients will be under general anaesthesia.

The patient needing the tendon repair has previously had MRSA and there is no evidence if the patient has had a recent negative swab, so precautions are necessary.
