This mark scheme has been written by the assessment writer and refined, alongside the relevant questions, by a panel of subject experts through the external assessment writing process and at standardisation meetings.

The purpose of this mark scheme is to give you:

- examples and criteria of the types of response expected from a student
- information on how individual marks are to be awarded
- the allocated assessment objective(s) and total mark for each question.

### Marking guidelines

#### General guidelines

You must apply the following marking guidelines to all marking undertaken throughout the marking period. This is to ensure fairness to all students, who must receive the same treatment. You must mark the first student in exactly the same way as you mark the last.

- The mark scheme must be referred to throughout the marking period and applied consistently. Do not change your approach to marking once you have been standardised.
- Reward students positively giving credit for what they have shown, rather than what they might have omitted.
- Utilise the whole mark range and always award full marks when the response merits them.
- Be prepared to award zero marks if the student's response has no creditworthy material.
- Do not credit irrelevant material that does not answer the question, no matter how impressive the response might be.
- When allocating marks across assessment objectives (AOs) within an individual response, these should logically link and should not be from disparate points of indicative content provided in the mark scheme.
- The marks awarded for each response should be clearly and legibly recorded in the grid on the front of the question paper.
- If you are in any doubt about the application of the mark scheme, you must consult with your team leader or the chief examiner.

#### **Guidelines for using extended response marking grids**

Extended response mark grids have been designed to assess students' work holistically. They consist of band-based descriptors and indicative content.

Band-based descriptors: each band is made up of several descriptors for across the AO range; AO1–AO3, which when combined provide the quality of response that a student needs to demonstrate. Each band-based descriptor is worth varying marks.

The grids are broken down into bands, with each band having an associated descriptor indicating the performance at that band. You should determine the band before determining the mark.

Indicative content reflects content-related points that a student may make but is not an exhaustive list. Nor is it a model answer. Students may make all, some or none of the points included in the indicative content as its purpose is as a guide for the relevance and expectation of the responses. Students must be credited for any other appropriate response.

#### Application of extended response marking grids

When determining a band, you should use a bottom-up approach. If the response meets all the descriptors in the lowest band, you should move to the next one, and so on, until the response matches the band descriptor. Remember to look at the overall quality of the response and reward students positively, rather than focusing on small omissions. If the response covers aspects at different bands, you should use a best-fit approach at this stage and use the available marks within the band to credit the response appropriately.

When determining a mark, your decision should be based on the quality of the response in relation to the descriptors. You must also consider the relative weightings of the assessment objectives, so as not to over/under credit a response. Standardisation materials, marked by the chief examiner, will help you with determining a mark. You will be able to use exemplar student responses to compare to live responses, to decide if it is the same, better, or worse.

You are reminded that the indicative content provided under the marking grid is there as a guide, and therefore you must credit other suitable responses a student may produce. It is not a requirement either that students must cover all the indicative content to be awarded full marks.

Lott UK is a medium-sized business with a long established workforce. The teams use a collaborative approach to complete projects. Lott UK is looking into migrating its workforce so that all office-based staff will work from home full time. The business is assessing communication access for staff.

Discuss the factors that Lott UK will need to consider to reduce the possibility of potential isolation for its workers.

#### AO3 = 3 marks

Award **one** (AO3) mark for each discussion point of the factors Lott UK will need to consider to reduce the possibility of potential isolation for its workers, up to a maximum of **three** marks. For example:

workers will need time to transition to working from home as they are used to being in an
established team in an office environment (1). The company will need to ensure that they

- support staff while they settle into their new routine and the mindset of working from home by making sure that there is a clear communication strategy that is understood by all staff (1), and that workers are confident in the use of the remote communication platforms to reduce the possibility of potential isolation (1)
- the business will need to consider that workers must have the appropriate resources made available to them so that they can continue to do their job without difficulty and maintain collaborative working practices (1). They should ensure that staff have the confidence to use the kit and the platforms in a remote environment (1). Staff should be encouraged to access support from other members of the team if they do experience any problems (1)
- the business should consider if it has the infrastructure to support connectivity where workers are in a more remote location (1), and that it can provide alternatives to using the workers' home internet where needed (1). This will ensure that all staff can work collaboratively and connect with each other, no matter where they are based (1).
- 4 Landingham Services is a consultancy business that advises office staff on how to use digital technology safely. The business specialises in physical problems. A client has a large number of staff who suffer from headaches and back pain as a result of the way they operate their computers.
  - a) Identify two mitigation techniques that can be used to reduce the physical problems associated with using computer screens for extended periods of time.

  - b) Explain why one of the identified mitigation techniques would be recommended by Landingham Services.

- a footrest would provide the office staff support for a better posture (1), reducing the risk of back pain (1)

- screen filters could be fitted to monitors to modify the type of light emitted (1) leading to fewer headaches as staff are not affected by certain types of light frequency (1)
- regulation of use would ensure office staff take appropriate breaks (1), reducing the risk of
  effects on their health such as sleep problems or mental health impacts (1)

5 Let by T is a digital business that rents houses and flats to tenants. The business works with homeowners and finds suitable tenants to occupy their properties for fixed-term contracts.

The business aims to maximise profits for its homeowners. The business is a partnership and has been owned by the same family for over 50 years. All funding for the business comes from retained profit.

a) Identify two external stakeholders.

b) Describe how one of these stakeholders may be affected by the activities of this business.

- Customers/tenants (1)
- homeowners / property owners (1)
- competitors (1)

#### Accept any other suitable response.

- b) Award **one** (AO2) mark for each point in the context of Let by T, up to a maximum of **two** marks. For example:
- customers/tenants will want to have a reasonable price for renting a home (1) which may mean they are unable to pay higher rents as the business wants to maximise profits (1)
- homeowners / property owners will want to have their properties occupied and bringing in an income all year round (1) to ensure they are getting the best return on their investments and not having houses sitting empty, losing potential earnings (1)
- competitors are likely to have lower profits as a result of the businesses operations (1) as the business has been established for a long time and is likely to have a good reputation, attracting customers (1)

• local governments are likely to want homes to be occupied so they earn tax revenue (1), meaning that they will generate higher tax revenues when the business is running well (1).

#### Accept any other suitable response.

6 Butterfield Ltd supplies dairy products to supermarkets, many of which have demanded lower prices to pass on to their customers.

The business has been affected by an increase in interest rates and a long period of recession in the last year. The business has recently borrowed a large amount of money to invest in new machinery.

Explain the impact of two economic factors that are currently affecting Butterfield Ltd.

#### AO2 = 4 marks

Award **one** mark for each explanation point made for each economic factor that currently affects Butterfield Ltd, up to a maximum of **four** marks. For example:

- the business will experience higher costs of repaying its loans due to rising interest rates
   (1) which will have a significant impact on the finances of the business as it has recently taken out a large loan (1)
- the business will have lost income as a result of a period of recession (1) which will lead to pressure on profits as supermarkets seek lower prices to pass on to their customers (1)
- Butterfield will be affected by increasing productions costs (1) as the price of raw materials and electricity have risen (1).

#### Accept any other suitable response.

A chocolate manufacturer would like to reduce the variety available in its seasonal gift box and is planning to conduct market research to gain customer feedback to help inform the decision of which chocolate to remove from the gift box. A data technician will analyse the customer feedback and prepare a report for the chocolate manufacturer.

Explain how both quantitative and qualitative market research could be used by the data technician in their report.

Award **one** (AO2) mark for each explanation point of how quantitative market research could be used by the chocolate manufacturer to inform this decision, up to a maximum of **two** marks. For example:

• to create a survey with a numbered scale attached to each chocolate type to measure customer satisfaction (1) in order to identify which ones are most popular / least popular (1).

Award **one** (AO2) mark for each explanation point of how qualitative market research could be used by the chocolate manufacturer to inform this decision, up to a maximum of **two** marks. For example:

• to engage with the customer by means of, for example, a questionnaire or interview to gather their thoughts and opinions on the chocolates (1) in order to identify why customers, have the preferences / dislikes that they do (1).

Accept any other suitable response.

8 CJJ Co have recently digitalised operations in their warehouse and factory. They have introduced an app that allows staff to share information about quality issues and managers can now access detailed database reports on production statistics.

Many systems are now automated. For example, daily reports on production errors and delivery times are emailed to staff. Managers now work from home but can access the control systems for the factory from their laptops.

Assess the value that digitalisation brings to the operations function of CJJ Co.

#### AO3 = 3 marks

Award **one** (AO3) mark for each assessment point, up to a maximum of **three** marks. For example:

- the business will have enhanced communication channels as the app allows the reporting of
  quality issues (1) which will mean that the business is able to rapidly gather intelligence on
  any problems as they arise (1), allowing swifter interventions in response to production
  errors (1)
- internal reporting systems are automated, leading to important management information being emailed to managers automatically (1), saving time/reducing costs because administrative staff do not have to manually run reports and email them to managers (1) enabling administrative staff to address other issues/work (1)

 managers can control machinery from their laptops using a web portal, allowing greater flexibility (1); meaning that higher calibre/more diverse candidates could be attracted to these roles (1) and this may result in more ideas/development of the company due to the diverse workforce (1)

#### Accept any other suitable response.

D-Moss Dev is a small software development company that focuses on applications for clients in the farming industry. The business creates systems to control the production of tractors and other equipment and are regularly researching new uses for their apps. They also develop money management systems that allow farmers to keep track of money spent and earned.

Discuss ways that digitalisation may affect the processes used by D-Moss Dev. [3marks]

#### AO3 = 3 marks

Award **one** (AO3) mark for each discussion point of the ways that digitalisation will affect the processes used by D-Moss Dev, up to a maximum of **three** marks. For example:

• staff at D-Moss Dev may have to change their coding methods to respond to new types of manufacturing equipment in order to get the best out of them; leading to staff having to change their workflow in order to adapt to the requirements of coding for a new type of hardware system (1). As the financial needs of their clients change, programmers may have to change the data sources that their money management apps use; in order to pull data from the correct source such as the funding systems used to pay subsidies (1). Research may lead to new innovations being discovered that the mangers of D-Moss Dev believe they can exploit profitably; leading to new teams being formed and having to establish new workflows in order to adapt to the new opportunities (1).

#### Accept any other suitable response.

10 Sherborne Seaborne is a shipping company that is planning to digitalise its staff management systems. The company has operated in the UK for 50 years and many staff are very reluctant to adapt to the new system being proposed. The marketing department is particularly concerned about the impact of the changes on workload.

The management team is preparing a plan to implement their new systems. A survey shows that staff do not understand the proposed changes or why they have been proposed.

Discuss the technical change management preparation and planning that should be carried out by Sherborne Seaborne in order to successfully implement their new systems.

14 To-By is an educational publishing business. The business uses virtual machines to work with writers and editors who live and work in different countries. They regularly need to move large amounts of data around the world.

In meetings, staff often have to work together on a single document, sharing screens. The business has built a brand image as environmentally friendly and prides itself on sticking to this reputation.

a) Identify one benefit of using virtual machines to the business.

b) Explain how the identified benefit of using virtual machines will impact on To-By.

- a) Award **one** (AO1) mark for a benefit to To-By. For example:
- more cost effective in larger digital environments (1)
- easier to manage and maintain larger environments (1)
- environmental (for example lower carbon footprint) (1)
- disaster recovery options (1)
- efficient testing environments (1)
- education and training platform (1)
- resilient (1).

#### Accept any other suitable response.

- b) Award **one** (AO2) mark for each explanation point of the impact of To-By using virtual machines, up to a maximum of **two** marks. For example:
- the business is large, operating over multiple countries meaning that virtual machines would be more cost effective than a physical infrastructure (1) due to the lack of a need of fixed machines and servers which are more expensive to set up and maintain (1)
- the business operates flexibly over multiple countries which would make a normal infrastructure difficult to maintain (1). However, a series of virtual machines could be

- hosted in one place and maintained by a dedicated team making it easier to manage the systems needed by the business (1)
- the business has a reputation for being environmentally friendly which it can maintain by using virtual machines (1). This type of infrastructure will require fewer physical machines and less hardware, leading to less pollution, which will help the company maintain that reputation (1)
- a virtual machine can be backed up onto a hard drive and quickly restored, leaving the business with more disaster recovery options (1). This means that software issues on individual users' PCs can be fixed remotely, without impacting on the individual's productivity (1).

#### Accept any other suitable response.

Booj is a communications company that trains technical staff for digital businesses. The management are producing a staff guide to network protocols. Their new client wants staff to understand which email clients can be used by staff for different tasks.

Describe two email protocols that could be included in Booj's guide.

#### AO2 = 2 marks

Award **one** (AO2) mark for each description of an email protocol which is relevant to Booj's guide, to a maximum of **two** marks. For example:

- simple mail transfer protocol (SMTP) is used to send email messages transferring binary files using the MIME format to and from Booj staff who wish to share information in a text based format (1)
- internet message access protocol (IMAP) stores emails on a server but allowing messages to be accessed as if they were stored locally (1)
- post office protocol (POP3) allows the downloading of emails from a remote server belonging to Booj, for tasks such as sharing data with clients (1).

#### Accept any other suitable response.

Noah has recently started a new job as a network engineer for a national esports team. The team have recently lost a number of high-profile tournaments due to a delay in gameplay.

The team have been using a VPN but would like Noah to advise them whether they should stick with VPN or use WAN instead.

Assess which option would be the most suitable network for Noah to use for the esports team.

#### AO3 = 3 marks

Award **one** mark for each assessment point of why WAN would be the most suitable network for Noah to use for the esports team, up to a maximum of **three** marks. For example:

- A VPN is suitable for the Esports team as VPN's will give the team a stable internet connection which will solve the problem which caused them to lose the previous tournaments (1). A gaming VPN could reduce issues for Noah such as a high ping and latency which means messages between the PC's takes longer as the VPN would be well maintained and updated reducing the chances of the data being slow (1) and this could increase their chances of winning (1)
- A WAN network would be the best network for Noah to use for the esports team. A WAN will also enable the esports team to take part in tournaments remotely (1) rather than requiring all the teams to physically travel to the same location in order to play in the tournament. This will enable them to take part in more tournaments and as they are directly connected to the network, rather than going through a VPN (1) which could slow down the data transmission. This should reduce the chances of them losing due to technical issues (1) WAN's are faster due to more direct internet traffic routing to wherever the tournament is being played as opposed to via wherever the VPN breaks out as well as the privacy overhead (1)

17 Felenders is a manufacturer of musical instruments. The management of the business have implemented a more resilient digital environment after a number of security problems. Hackers had attempted to penetrate systems to steal designs and staff data had been stolen by an unhappy employee.

a) Identify two benefits of a resilient digital environment.

b) Explain how one of these benefits could help to protect Felenders against the security problems that they have faced.

- secure transfer of data (1)
- secure storage of data (1)
- reduced system vulnerabilities (1)
- reduced probability of targeted cyber attacks (1)
- Increased security (1)
- Increased reputation (1)
- less downtime (1).

#### Accept any other suitable response.

- b) Award **one** (AO2) mark for each explanation point of how one of the identified benefits could help to protect Felenders, up to a maximum of **two** marks. For example:
- by implementing a secure transfer of data, data will be protected, for example, by encryption, which would prevent information being intercepted by anyone without the relevant permissions (1), reducing the risk of designs being stolen by hackers (1).
- secure storage of data means that unauthorised people will not be able to access sensitive information such as personnel data due to user permissions / physical access, (1), meaning that the business will have more control over which employees can access this sensitive information, reducing the risk of a data breach (1)
- Increased security (e.g Multifactor authentication) securing not just the username and
  password but also the device that they are using is a great additional layer of security (1)
  as hackers would need not just to compromise the users account but also the device that
  they are using. (1)

Financial contingency planning can be used by the design agency to ensure that adequate funding is in place, should the uncertain economy cause unexpected changes in costs. By setting aside a contingency budget, the business can ensure that they will be able to account for all expenditure even if there is an overspend. This means that the business is complying with the terms of the government grant (1). Budgeting should be based on documented assumptions so that analysts can understand the basis by which figures have been set so that precise targets for spending can be monitored, explained and analysed accurately (1).
