- four mandatory units, four optional units from Optional Group A and four optional units from Optional Group B within this qualification (all units are graded A\*-D)
- an external assessment short answer question paper graded A\*-D for mandatory unit anatomy and physiology for health and social care - and an external synoptic extended assessment graded A\*-D covering the remaining mandatory units
- a minimum of 100 placement hours
