About this qualification

This qualification is designed to support the development of registered managers of adult social care services. The qualification provides learners with the knowledge and skills needed to work in adult social care and to have responsibility for leading and managing a service. This will include managing and improving care and support for individuals accessing the service, supporting and developing the workforce, and driving the vision for their service or organisation.

It covers a wide range of topics including:

- leadership and management
- governance and regulatory processes
- quality assurance
- safeguarding, protection and risk
- · communication, relationships and partnership working
- person-centred practice for positive outcomes
- managing personal wellbeing
- professional development, supervision and performance management
- decision-making skills
- entrepreneurial skills and innovation
- the management of specific services

Developed with and supported by Skills for Care, this qualification has been designed to meet the requirements for the apprenticeship standard for Leader in Adult Care.

To be awarded this qualification, learners are required to successfully achieve a minimum of **95 credits**: **80 credits** from the mandatory units and a minimum of **15 credits** from the optional units.
