Student instructions

You must:

- undertake research to gather information that will support you to complete the supervised planning activities.

Your tutor will be available to guide and support you during this supervised preliminary research.

Preliminary information

In your role as an early years educator, you are required to support the care, learning and development of all children. In order to do this, you will plan educational activities to promote children's progression.

The information below is to help you prepare for assignment 2; to complete this assignment, you **must** plan **two** educational activities (one for each educational activity) that support areas of learning in the early years foundation stage (EYFS).

Educational activity 1: plan a single educational activity that **must** focus on **communication and language**.

Educational activity 2: plan a single educational activity that **must** focus on **personal**, **social and emotional development (PSED)**, particularly **supporting children to manage their own health and wellbeing**.

Both educational activities will be planned to support children aged **4 to 5** years and **each must** be at least **20 minutes** in length.

You have **1 week** of preparation before you must write your first activity plan. After completing the writeup of educational activity 1, you will then have a further **3 days** before you write up your plan for your second educational activity. You will **not** be able to bring your planning with you to use in the assessment.

In the assessment, you will be provided with further information about the group of children you are planning for.
