

Qualification overview

NCFE CACHE Level 3 Extended Diploma in Health and Social Care (Adults) (Northern Ireland) (603/5355/7)

This qualification is designed to provide learners with the knowledge, understanding and skills essential to the health and social care sector within Northern Ireland, and to support progression into Higher Education or the workplace.

The qualification is formed of mandatory and optional units.

The mandatory units cover core competencies, while the optional units allow learners to choose from a variety of areas to tailor the qualification to their needs and interests, and to reflect the context of their work.

Learners will need to achieve a pass grade from the Level 3 Diploma in Health and Social Care (Adults) (Northern Ireland).

Learners will also need to achieve the four mandatory units, four optional units from optional group 1 and four optional units from optional group 2 within this qualification (all units are graded A^*-D).

In addition, learners will need to achieve an external assessment graded A*– D for mandatory unit 04 and a synoptic external assessment covering the relevant mandatory units.

The total qualification time is 1395 hours and the minimum guided learning hours for the qualification is 1085 hours. This includes a requirement for learners to attend placement in a real work environment to support their learning. The minimum required number of placement hours is 100 hours

Centres are responsible for checking that learners have already achieved the Level 3 Diploma in Health and Social Care (Adults) (Northern Ireland) qualification prior to requesting certification for this qualification.

Entry requirements

Learners should be at least 16 years old. We do not set any other entry requirements but Centres may have their own guidelines.

Real work environment (RWE) requirement/recommendation

Learners will be required to attend placement in a real work environment to support their learning.

Assessment

All units will be internally assessed and graded A^* – D except mandatory unit 01 which will be externally assessed and graded A^* – D.

There will be **one** externally set and externally marked synoptic assessment covering the content of mandatory units 01–03.

Synoptic assessment enables the learner to show their ability to integrate and apply knowledge, understanding and skills with breadth and depth. It also requires them to demonstrate their capability to apply knowledge, understanding and skills across a range of units and learning outcomes which are being assessed.

All units must be assessed in line with the Level 3 Extended Diploma in Health and Social Care (Adults) (Northern Ireland) Assessment Strategy and Principles.

Assessment enables the learner's workplace practice to provide evidence for individual units, as well as the whole qualification through a portfolio of evidence.

Methods of assessment could include:

- direct observation of learner by assessor
- witness evidence when directed by the sector skills assessment strategy
- professional discussion
- reflection on own practice in real work environments
- written assignments
- learner's own work products.

Duration

Learners can usually complete the qualification within 12 months.



Career opportunities

Upon completion, learners can progress to the Level 5 Diploma in Health and Social Care (Northern Ireland), Higher Education or into a wide range of job roles within the health and social care sector in Northern Ireland.

Funding

Funding in Northern Ireland will be sought for this qualification.
