About this qualification

This qualification is designed for those who are working as a trainee dental nurse and who wish to register with the General Dental Council (GDC) and qualify as a dental nurse.

This qualification covers all of the GDC learning outcomes and maps to Skills for Health's national occupational standards (NOS).

It is not suitable for the Dental Nurse Apprenticeship Standard in England. Learners wishing to take the qualification as part of the apprenticeship standard in England should select the Level 3 Diploma in the Principles and Practice of Dental Nursing (Integrated Apprenticeship).

This qualification comes with a comprehensive set of sample assessment tasks and associated marking guidance covering 100% of the knowledge outcomes within the qualification. These are provided free of charge to centres.

Qualification structure

Learners must achieve 49 credits from the 17 mandatory units.

All knowledge and skills learning outcomes and assessment criteria must be met for each unit. In addition, learners must achieve a pass, merit or distinction in the 2 external assessment tests (part 1 and part 2) covering the underpinning knowledge across units DN 12 to 16.

Assessment

Learners must achieve 49 credits from the 17 mandatory units. All observations must be fully achieved, and learners must achieve a pass, merit or distinction in the 2 multiple choice external assessment tests (part 1 and part 2) covering the underpinning knowledge across units DN 12 to 16.

There is no compensation between units, or between observations and unit tasks within a unit.

Placement requirements

Learners will need to be working or on practical placement to be able to show competence in both knowledge and skills.

It is recommended that a minimum of 16 hours per week be spent in a real work environment.

Learners may progress into employment as a dental nurse or to other career pathways including:

- orthodontic therapy
- dental practice management
- oral health practitioner
- dental technician
- dental hygienist
- dental therapist.
