Audio visual recordings				
Audio-visual recording of mid-stream urine collection: 1(b)(i)	Covering each step, to be labelled with the student and provider name. The recording should capture the student carrying out the mid-stream urine collection, labelling and registering the patient sample, including all communication with the patient.			
Audio-visual recording of urine dipstick testing and referring second sample to microbiology for testing: 1(b)(ii)	Covering each step, to be labelled with the student and provider name. The recording should capture the student carrying out a urine dipstick test, recording results and referring second sample to microbiology for testing, including all communication with the senior colleague and patient.			
Audio-visual recording of post-examination cleaning and storage of equipment: 1(c)	Covering each step, to be labelled with the student and provider name. The recording should capture waste disposal, decontamination of medical equipment and infection control procedures to include disposal of PPE.

Photograph of room set up for mid-stream urine collection and dipstick testing	Showing the work area prepared by the student, to include equipment and set up, to include a unique student identifier (for example, enrolment number).
