About this assignment

Introduction



You **must** answer the following **four** questions.

You should spend the first part of this assessment reading the observation data provided in the insert. You should do this before attempting to answer the questions.

Q 1 Identify **and** describe the **two** different methods of observation (provided in the insert) that were used to assess Natalia's development in **expressive arts and design**.

[4 marks]

Q 2 Using an example, evaluate the purpose of **each** of the **two** methods of observation identified in **question 1** in the assessment of children.

[6 marks]

Q 3 With reference to the insert, analyse **each** of the **two** observations to draw conclusions about Natalia's holistic developmental needs, as identified through **expressive arts and design**. In your answer, you **must** relate to the current requirements of the early years education curriculum.

[12 marks]

Q 4 Use your analysis of the two observations to discuss the next steps for Natalia's holistic developmental needs, through **expressive arts and design**. Give examples of suitable educational activities or opportunities to support your answer.
